## **RULES.**

1. No bitch in season will be allowed on ground.
2. Every dog competing must be on leash when not running. No dog, unless entered, will be allowed on the Trial Ground.
3. No Competitor may enter more than two dogs.
4. The owner of any dog which injures a sheep will be held liable for the damage done.
5. Competitors not ready to run when their names are called will be disqualified; and no reason whatsoever will be accepted by the Committee.
6. The Judge will have full power to determine what work the dogs must do.
7. The Judge will be at liberty to stop a dog at any point of his trial, and his decision in all cases is final.
8. TIME ALLOWED for completion of course will be TWELVE MINUTES. No extension. The Course Director will explain to Competitors what they are expected to do.
9. Competition to start at EIGHT O'CLOCK A.M. PROMPT.
